

The NHRA Giveaway

NO PURCHASE OR PAYMENT OF ANY KIND IS NECESSARY TO ENTER OR WIN. THE CONTEST IS VOID WHERE PROHIBITED BY LAW.

1. How to Enter the Contest:

- (a) The NHRA Giveaway will begin on Monday, April 15, 2019 at 9:00pm and end on Monday, April 22, 2019 at 11pm. The contest is sponsored by CW69 and The National Hot Rod Association.
- (b) To participate in the contest, contestants must watch Arrow between 9 and 10pm on either April, 15, 2019 and/or April 22, 2019, and look for the code word. When the code word is displayed, contestants may enter by going to <http://atlcw.tv> and follow the links to the contest page. Enter the code word and other contact information in the form and you will be entered into the contest. You have until 11pm the same day to enter the contest.
- (c) Contestants are limited to one (1) entry per day.
- (d) Sponsor is not responsible for technical or computer failures, errors or data loss of any kind, lost or unavailable Internet connections, or failed, incomplete, garbled or deleted computer or network transmissions, inability to access any Web site or on-line service, or any other error or malfunction, or late, lost, illegible or misdirected entries. Entry materials that have been tampered with or altered are void. If the judges determine, in their sole discretion, that there is any suspected or actual electronic tampering with the Contest or if technical difficulties compromise the integrity of the Contest, the judges reserve the right to void the entries at issue and/or terminate the Contest and conduct a random drawing to award the prize among all eligible entries received as of the termination date. If the Contest is terminated due to tampering or technical difficulties prior to its expiration date, notice will be posted at www.atlcw.tv

- (a) The contest is open to the state of Georgia residents who are 18 years of age or older. Employees of WUPA-TV, CBS Corporation, other television and radio stations in the Atlanta market, and their affiliates, subsidiaries and advertising agencies and their immediate family members and persons living in the same household are ineligible to participate or win.
- (b) Viewers are eligible to win a WUPA-TV contest only once every sixty days. Only one winner per household is permitted in any contest. Viewers are eligible to win a prize valued at \$600.00 or more only once every six months.
